Note: OneMain has amended the definition of "Charged-Off Loan" in order to conform to the definition used in Springleaf's Credit and Collection policy. The revised definition resulted in a Loan (other than a Deceased Loan) being considered a "Charged-Off Loan" under the relevant transactions if such Loan is more than six payments contractually past due; provided, that determinations of charged-off status with respect to any Loan shall be made no later than the last day of the Collection Period immediately following the Collection Period in which the event or circumstance giving rise to the charged-off classification occurs. The revised definition of "Charged-Off Loan" took effect for the December 2015 Collection Period. This one-time impact to migrate to the policy is reflected in the Charged-Off Loans and the Monthly Net Loss reported in the Servicer Certificate for the December 2015 collection period. The one time impact to the month of December was immaterial to the Trust. All future reporting will reflect the new policy impact for the charged-off loans.
